The Montgomery County Transportation Improvement District (the "TID"), in cooperation with the City of Centerville, Sugarcreek Township and Greene County, is preparing a multi-jurisdiction application for funding of proposed improvements along the I-675/Wilmington Pike corridor. The TID's Board of Trustees approved Resolution 2021-15 at the March 8, 2021, meeting authorizing the submission of a Tier 2 application in support of the project.


