Community Health Centers of Greater Dayton (CHCGD) is planning to build a new community health center at 630 E. Dixie Dr., West Carrollton, Ohio 45449. This new stand-alone 11,700 square foot building will provide convenient access to care for patients located in West Carrollton, Miamisburg, and the surrounding communities. This new West Carrollton Health Center will replace the CHCGD Alex Central Health Center in Miamisburg which is located in a strip mall approx. 2.7 miles away and increase access to comprehensive primary care services for low-income community members who reside in the new zip code, 45449 and the current zip code, 45342.

Community Health Centers of Greater Dayton (CHCGD) purchased a 1.4-acre vacant lot at 630 E. Dixie Dr. in August 2022. The design of the new facility has been finalized and reviewed by key members of the city of West Carrollton. They are very complimentary of the project and feel it fits well with their River District being planned for the area.

We are estimating that the total project will cost approximately \$3.7 million. CHCGD has received \$697,000 in ARPA Capital funding from HRSA and \$250,000 from Montgomery County. We are in discussions with the Dayton Port Authority on some financing options. We also believe there is an additional opportunity to secure more funding from Montgomery County. However even if all of these sources of funds are secured, we will still have a gap. Therefore, we respectfully request \$1.1 million to complete the financing needed to move the project forward.
