Thank you for your application for the Transportation Alternatives Program. Considerable time and effort were spent reviewing each application for its transportation need, costs, and benefits to the local community. The Ohio Department of Transportation (ODOT) is pleased to inform you that the Great Miami Riverway Recreation Trail Project has been selected for funding in the Transportation Alternative Program.

In the past, ODOT has provided 80% of the eligible costs in Federal funds through the Transportation Alternatives Program. This year the Bipartisan Infrastructure Law allows TAP projects to be funded using 80% Federal TAP funding matched with 20% Federal Safety funding. The Great Miami Recreation Trail Project has been awarded \$4,200,000 in Federal funds. These funds will be available in State Fiscal Year 2026.



Tony:

Below is a summary of the two projects.

The attached map shows a concept for the east-west, mutli-use trail project, which will connect to an existing walkway from the west side of Sidney, that will then pass near the city center, and on to Custenborder Fields and Tawawa Park. It also maps out the continuation of the Canal Feeder Trail (Great Miami Recreational Trail) from Graceland Cemetery into downtown Sidney. The Canal Feeder Trail extension will utilize Miami-Erie Canal land, along with CSX Railroad spurs that are no longer in use, to provide the connection into the city from the Great Miami Recreational Trail. A pedestrian bridge will be installed to cross State Route 47, utilizing the existing railroad bridge abutments. This crossing will provide access to an old railroad depot site and create a "hub" for the connection to the east-west trail, with a future option of connecting the northern area of the city.

The cost estimate for the east-west connection from the Highland Ave., 10' walkway to the Stolle Bridge, over the Great Miami River and into Custenborder Fields and Tawawa Park is, \$900,000.00. This .9 mile trail will connect the western neighborhoods of Sidney to the residents living on the east side of the city and into the 226 acre Tawawa Park. Extending the Canal Feeder Trail from Graceland Cemetery, into the downtown and connect with the east-west trail is roughly 1.5 miles and estimated to cost, \$4,100,000.00. This project will connect downtown Sidney to Shelby County's efforts to close the gap between Sidney and our friends to the south in Miami County and beyond, along the Great Miami Recreational Trail.

Dear Kaitlyn Dwyer,

Shelby County's request is for completion of 2.3 mile segment of the Great Miami Riverway Recreational Trail from Kuther Road, Sidney to the Village of Lockington, Shelby County. A committee has been meeting for at least five years and is comprised of Tony Bornhorst, Shelby County Commissioner; Duane Gaier, City of Sidney Park Director; Mark Cundiff, former Sidney City Manager; current Sidney City manager Andrew Bowsher; Choice One Engineering staff; Dan Foley, Director of Great Miami Riverway; Scott Myers, Director of Miami County Park District; James Hill, Sidney Shelby Economic Partnership; and Jeff Raible, Sidney Shelby Chamber of Commerce. This segment's completion has been a collaborative effort to connect Sidney to the Great Miami Riverway Recreational Trail.

I have attached a map of three proposed routes and a total project cost by Choice One Engineering. The total cost for the project is \$5,753,550.00 and Shelby County is asking for \$683,215.00 to provide for design, engineering and right-of-way projected cost. Shelby County has secured \$500,000.00 from the Ohio Capital Projects Grant. Shelby County has applied for \$3.9 million Ohio Department of Transportation, Transportation Alternative Project Grant. Shelby County is also able to apply for Clean Ohio Trails and Land and Water Conservation Grants in 2024. Shelby County has also reached out to business and private individuals for support.

The project timeline is to apply for ODOT TAP grant in 2023. If successful those grant dollars will be available for construction in late 2025. Applying for a Congressional Appropriation for funding for design and engineering in 2024. Apply for Clean Ohio Trails and Land and Water Conservation Grants in 2024 and to ask business and private citizens for contributions to the project. Start of construction in late 2025 with completion in 2026.

Shelby County has included Letters of Support that were presented to the Ohio Capital Projects Grant application in 2022. Shelby County looks forward to completion of the 2.3 mile segment of the Great Miami Riverway Recreational Trail. The project's contribution to Shelby County citizens and all of Southwest Ohio residents is impactful to recreational, economic and "place making" activities. Thank you for the opportunity to apply and with sincere appreciation to Representative Mike Carey for his support of Shelby County.
