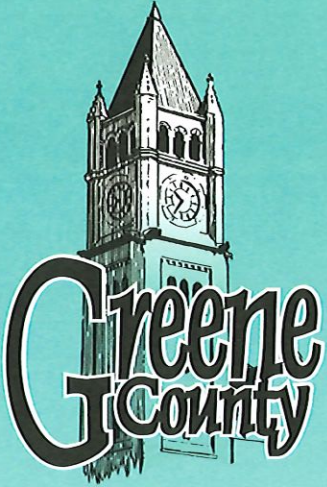
This partnership with Wright State University will allow the YMCA to continue serving the Fairborn community and provide numerous opportunities for those it serves.
