Dayton Cottage Village

The homeless issues facing our community require developing unique quality housing solutions for homeless citizens by reducing construction costs, while continuing to provide opportunities for tenants to have private space and services to address their needs and maintain housing stability.

To that end, MVHO will develop the Dayton Cottage Village with 25 approximately 400 square foot cottages, each with a bathroom, kitchen, and other necessities to make the unit a home. The cottages will have durable finishes and materials to reduce maintenance. The site will provide space for outdoor activities and a community center for services, case management, entertainment, and recreation. The site will be near public transportation with access to food and other services. The development is supported by the City of Dayton, with MVHO working closely with the city's Planning Department to select the most appropriate site and to utilize best practices for community engagement to maximize the opportunity to develop a community benefiting both tenants and neighbors. The initial cost estimate for the Village is approximately \$6.5M with the ability to add additional cottages for approximately \$140,000 each. The initial estimate includes sitework and the construction of the community center. One of the major impediments to meeting the housing demand is the exceptionally high cost of producing units as the per unit cost for projects developed under the tax credit program is currently well over \$300k.

MVHO has developed multifamily housing serving formerly homeless disabled individuals and families in Montgomery County for 34 years. Over those years, MVHO has developed experience working with governmental agencies at federal, state, and local levels. MVHO has also gained experience providing services to various populations, including street homeless, reentering citizens, and those in recovery. Today, MVHO houses and serves over 1,500 citizens in its properties and in property owned by private landlords.

MVHO has a long history of providing "homes" for the most vulnerable citizens in Montgomery County, owning and maintaining over 50 multifamily buildings. MVHO works to realize its vision, "a community where everyone has a place to call *Home*". The Village will provide housing opportunities for those who are not well-suited for multifamily buildings. MVHO helps clients address their mental and emotional needs by connecting them to benefits and resources, and providing resources needed to make their unit a home. MVHO has been home to the Project for Assistance with Transition from Homelessness ("PATH") Program for over 20 years. MVHO's PATH/Outreach Team provides support to individuals and families living on the street or places not fit for human habitation, connecting them to housing, benefits and services. The PATH/Outreach Team is acknowledged as the street homeless experts and routinely supports and trains law enforcement to improve homeless responses throughout Montgomery County.

MVHO provides Reentry Housing and Recovery Housing. Supported housing and services drastically reduces recidivism, resulting in major cost savings for the Ohio Department of Rehabilitation and Corrections. MVHO's oversight of Recovery Homes has increased funding opportunities for our recovery providers and better coordination of recovery services in Montgomery County.

MVHO has received wide ranging support for the project. The community is willing to work together to make this vision a reality. Housing For Hope Collaborative

A collaborative project in partnership with The Foodbank, Inc., Miami Valley Housing Opportunities (MVHO) and OneFifteen to provide a path to success with a stable living situation for the most underserved people in our community, with pathways to employment and services.

Goals:

To provide access to safe, permanent, affordable housing and supportive services in a community setting for individuals who are homeless, continuing their path to recovery, and to serve individuals who have been involved with the criminal justice system.

Total Request:

\$6.5 Million to build 30 housing units; secure safe affordable apartments with rental support and provide recovery support for people in recovery, reentering society after incarceration or those who have been involved with the criminal justice system, and those who are experiencing homelessness.

Project Overview:

For years our agencies continue to serve many of the same people. We refer clients to each other, support each other's missions, and strive toward many of the same goals.

As we work to achieve our missions and meet the community's needs, all three of our organizations see that stable, affordable, and permanent housing is one of the biggest barriers to sustained success in their journeys; and one that is nearly insurmountable for many of the people we serve.

This proposed project aims to address this barrier by leveraging our organization's strengths to alter the landscape of Dayton's affordable housing options, and avoid duplication of efforts.

Housing and employment are the strongest predictors of success for those we serve.

For people in recovery, people reentering society after incarceration or those who have been involved with the criminal justice system, and for people who are homeless or who lack financial resources, housing and employment are uniquely connected. If a person doesn't have housing and a permanent address, they often can't get a job. Without stable employment, it is impossible to be considered for or afford permanent housing. This is a difficult cycle to break for the people we serve in our collaborative, and can become a path to chronic homelessness, relapse, and recidivism.


